

INTERNATIONAL SCIENTIFIC INTERCHANGE AGREEMENT

between

**AUBURN UNIVERSITY
The Alabama Agricultural Experiment Station**

and

PRATHISTA INDUSTRIES LIMITED

and

SRI PADMAVATI MAHILA VISVAVIDYALAYAM

AUBURN UNIVERSITY, Auburn, Alabama, USA, **SRI PADMAVATI MAHILA VISVAVIDYALAYAM**, Tirupathi, Andhra Pradesh, India and **PRATHISTA INDUSTRIES LIMITED**, Secunderabad, Andhra Pradesh, India, wishing to develop cooperative relations on the basis of established contacts and mutual understandings, especially to develop scientific and cultural interchange through mutual assistance in the areas of research and plant variety development, agree as follows:

PART I

Area of Cooperation

The area of cooperation includes, subject to mutual consent and appropriate conditions, any program offered at either organization and proposed by either as desirable, feasible, and contributory to the fostering and development of the cooperative relationship between them.

PART II

Methods

All understandings and assistance shall be subject to availability of funds and the specific approval of the Director of the Alabama Agricultural Experiment Station of **AUBURN UNIVERSITY**, **SRI PADMAVATI MAHILA VISVAVIDYALAYAM**, and of the **PRATHISTA INDUSTRIES LIMITED**, through such activities or programs as:

1. Exchange of scientific and technical staff
2. Exchange of students and staff
3. Conduct joint research activities
4. Participation in seminars and meetings
5. Special short-term training programs
6. Cultural exchange activities

7. Exchange of plant genetic material
8. Joint licensing of varieties and cultivars
9. Degree training at Auburn and practical experience in China
10. Engage in consultancies
11. Other activities as deemed mutually appropriate.

The terms of such mutual assistance and necessary budget for each program and activity shall be mutually discussed and agreed upon in writing by both parties prior to the initiation of the particular activity or program. Furthermore it is understood that each institution will enter into specific program by program written agreements as required for compliance with the respective immigration regulations of the parties involved. Each organization will designate a Liaison Contact Officer to develop specific activities or programs for approval by the respective organizations.

PART III **Effective Date and Length of Agreement**

This agreement will remain in force for a period of five years subject to the availability of funds, and any amendment and/or modification of this agreement requires a written approval of each and all parties: the **Alabama Agricultural Experiment Station at AUBURN UNIVERSITY, SRI PADMAVATI MAHILA VISVAVIDYALAYAM** and that of **PRATHISTA INDUSTRIES LIMITED** and shall be appended hereto. After the initial five-year period, this agreement may be renewed by written consent of all parties.


Each party reserves the right to terminate this agreement upon six (6) months written notice to the others. Any individual activities to be continued will be specifically identified and provided for at the time of termination.

Each party shall be responsible for assuring full compliance by its participants with applicable laws and regulations, including insurance, of the respective nations.


